Humanitarian Appeals in the 21st Century

Welcome to participate in the construction of the world's first International Academy of Red Cross & Red Crescent(IARC)

The International Red Cross & Red Crescent Movement has a history of 156 years, covers 191 states and regions, has approximately 500,000 dedicated workers and hundred millions of members and volunteers. However, the Movement still does not have a university or college in the strict sense.

The ICRC and the IFRC support to establish a comprehensive International Institute of the Red Cross & Red Crescent in China.

With the support from the Chinese government, ICRC and IFRC, the IARC was founded on August 31th, 2019 in Suzhou, Jiangsu China. The Academy was jointly established by the Red Cross Society of China, Soochow University and Chinese Red Cross Foundation. It is an education and research institution, dedicating to study of the theories of the Red Cross Movement, talent cultivation, cultural diffusion and academic communication.

IARC will function as a platform for research and dissemination of the idea of a community of shared future for mankind, humanitarian cooperation along the route of the Belt and Road Initiative, and building up a global governance system on humanitarian affairs. It will play a unique role in humane supply side reform and humanitarian capacity building in the new era.

1 A base for professional trainings for China and the International Red Cross and Red Crescent Movement;

Operating System

Council

The Council members are from the Red Cross Society of China, Soochow University, China Red Cross Foundation, Jiangsu and Suzhou municipal government, major donors, experts, scholars and the dean of the Academy. They jointly discuss and decide on major issues concerning the development of the Academy.

The candidates of chairman and the vice chairman of the Council as well as president and vice-president of the Academy are nominated by Chinese and Soochow University and elected or appointed by the Council. The Honorary President is appointed by the Council. The first Honorary President is Mr. Francesco Rocca, President of the International Federation of Red Cross and Red Crescent Societies.

Faculty Council

A party committee will be established to take charge of the party affairs in the Academy.

The president, the party secretary, the executive president, and the vice president form the faculty council. They are responsible for daily teaching, research and other work and affairs.

Institutional Setting

Research Center

As a relatively independent teaching and research unit of Soochow University, IARC is planned to rely on the research center and set up an organizational structure, focusing on training program.

The research center is not only the research subject, but also the resource center for training courses development, curriculum design, textbook compilation and publication, and the training-related course undertaker.

(I) Red Cross Movement Research Center:

Responsible for the research and training of the courses of the history, culture, ethics and innovation theory of the Chinese and foreign Red Cross movements

(II) International Humanitarian Law Research Center:

Responsible for the research of the theory and practice within the international war, regional conflict and world peace research, military international humanitarian law dissemination training, simulation court and "exploration of humanitarian law", etc.

Edit and publish academic journals on the research and practice of international humanitarian law in China.

(III) "Belt and Road" International Exchange and Cooperation Research Center:

Focusing on the "Belt and Road" initiative, conducting targeted research on countries along the "China-Pakistan Emergency Corridor", providing intellectual support for China and international humanitarian cooperation and exchange, and undertaking the training duties of the National Red Cross and Red Crescent Society in Developing countries and countries in the Belt and Road

(IV) Nightingale Nursing Research Center:

Conduct research and business training in emergency care, elderly care, disaster medicine, etc., and provide theoretical guidance for the Red Cross to carry out the core business of "three rescues and three contributions".

(V) Human Resources Mobilization and Communication Research Center:

Conduct research and training on humanitarian culture communication and crisis management, human resources mobilization and management, design and fundraising of public welfare projects, new media and databases, and carry out research and development of Red Cross Wen Chuang brand.

(VI) Emergency Management and Disaster Preparedness Research Center:

In order to serve the new era of national emergency management system capacity building, we will undertake relevant special policy consultations and train various types of emergency management talents for governments at all levels Through research, collation, and experience, cases and courses in emergency management.

Carry out theoretical research on the Red Cross and national disaster preparedness and relief, compile relevant business training and science textbooks, and develop business training such as disaster management and disaster relief skills.

(VII) Red Cross Movement Database (Red Cross Network Academy):

Collect, organize, and publish international Red Cross data and establish a Red Cross online course.
